The Competent Authority is pleased to establish the following **Monitoring Cell to ensure the smooth supply and availability of wheat and flour** at notified prices in the open market, and to prevent hoarding, artificial price hikes, and profiteering of these essential commodities:

2. **The Terms of Reference (TORs) of the Monitoring Cell** shall be to:
- i. Monitor the availability of wheat, flour and roti at the notified prices;
 - ii. Oversee field surveys and inspections conducted by the district-level teams for the prevention of hoarding, artificial price escalation, and profiteering of wheat and flour;
 - iii. Monitor the issuance of QR-coded permits for the out of province movement of wheat and flour, and to consolidate the same for incorporation into the daily report;
 - iv. Consolidate and compile daily and weekly reports on the actions taken by the field teams, and
 - v. To submit consolidated daily reports to the Director General (Food)/Cane Commissioner for onward transmission to the Secretary, PC&CM Department, and the Chief Minister's Office.
3. The Cell shall be stationed in the office of Secretary, Price Control & Commodities Management Department, 2-Bank Road, Lahore.
